Höngongoi July 2021

Nau mai, haere mai. Welcome to this update from the Kaipara Moana Remediation Programme – working together to restore the health and mauri of Kaipara Moana.

Te huarahi mai i te tīmatanga o te kaupapa What's happened since the programme started

It has now been nine months since the Kaipara Moana Remediation Joint Committee was formed in October 2020, and four months since the Deed of Funding was finalised and Crown funding of \$9.6 million for Year One was released.

The last six months have been a hive of energy developing the systems, processes and structures needed for the programme, while also seeing practical wins on the ground. Some of the key mahi has been:

- Developing the work plan and budgets for 2021/22
- Developing strategies to support the programme around communications, nursery capacity, and workforce and procurement
- Assessing the capacity of nurseries and the workforce needed to carry out fencing and planting
- Developing a hapū and community partnerships scheme
- Developing the landowner grants scheme
- Holding public Joint Committee meetings at seven marae around the Kaipara
- Setting up the operational body for the programme, Kaipara Maurikura.
- Progressing over \$1,000,000 in assistance to on-farm remediation work.

It's been a hugely busy period laying strong foundations for this decade-long, \$300 million programme, and we know that restoring Kaipara Moana will take the commitment and action of everyone who lives and works in the catchment.

What's planned for the coming year



Remediation work is set to grow across the Kaipara catchment in the coming year, following the adoption of the programme's \$17 million budget and work plan for 2021/22.

The focus for this year will be providing funding support to landowners for riparian and wetland fencing and planting.

Along with landowner grants through sediment reduction plans (see below for more detail), we are working with Fonterra to develop a scheme where dairy farmers can access Kaipara Moana support through their Sustainable Dairy Advisor.

Opportunities for hapū, marae and community groups will also be provided, so they can work with landowners on remediation projects.

Other priorities for the year include developing digital tools to help map sediment hot spots and wetlands, and a soil conservation strategy to identify the best ways to stabilise highly erodible land through tree planting in future years of the programme.

Several projects already underway will continue, including working with two community groups which are supporting landowners to undertake fencing and planting.

Te tahua aki whenua Landowner grants scheme



Landowner grants under Kaipara Moana Remediation Programme are expected to be available this September. In the meantime, here is an overview of how the scheme will work.

To receive funding a landowner will need a 'Sediment Reduction Plan', which is a free, property-specific plan, ideally covering three years, identifying sediment reduction opportunities such as riparian fencing to receive funding support.

Landowners will be able to arrange for an accredited field advisor to visit their property and help design a Sediment Reduction Plan. This plan will set out remediation work that would be most effective on the property and identify what's eligible for grants funding.

At this stage, the focus will be on land parcels of over 20 hectares. The primary focus initially is fencing and planting wetlands and waterways to create a buffer that protects waterways from sediment, with hillsides and slips to be targeted in future.

The pace at which Sediment Reduction Plans can be completed will hinge on timing for training field advisors and the level of interest shown by the community.

Hono ā-hapū ā-hāpori Hapū and community partnerships



Grants funding will be available to support hapū, marae, Landcare groups, schools and other community bodies to work with landowners, mana whenua groups and other partners to undertake remediation works.

Guidance and criteria for how that will work are being developed, and engagement with these groups will begin soon.

Te tohu tūranga mō Kaipara Maurikura Kaipara Maurikura recruiting for staff soon

'Kaipara Maurikura' is the name of the operations unit that is being set up to deliver on all the mahi set out in the work plan for Year Two and beyond.

Kaipara Maurikura reflects the health and vitality of Kaipara Moana, which will require positive collective action to survive.

For now, it has been set up as a business unit of Northland Regional Council (NRC) and will be based in the council's Whangārei office. The Joint Committee considered this the most straightforward approach given the Crown's funding requirements, plus it offers some efficiencies to keep Kaipara Maurikura operating costs low. This setup will be reviewed once a future statutory Kaipara Moana body is set up under Te Tiriti o Waitangi settlement processes.

Recruitment for the role of Pou Tātaki (Manager) for Kaipara Maurikura is underway and it is hoped that an announcement on that appointment can be made in August/September this year. In the interim, Alan Wilcox will step in temporarily to manage Kaipara Maurikura.

Pou Tātaki: Pou [noun] person with expertise, mentor, guide; Tātaki [verb] lead, conduct, urge.

Te āheinga ōhanga tupu Nursery capacity for plants



An enormous amount of planting needs to happen across the Kaipara to reduce sedimentation and restore the health and mauri of Kaipara Moana. As part of the nursery strategy, a team looking at local nursery capacity has found that there is sufficient capacity within existing local nurseries to expand and meet demand, which is really encouraging.

There are specific needs around the variation of species planted, taonga species, and local seed banks within the catchment. Nurseries run by Kaipara Uri entities can be supported to fill this need, which aligns well with programme objectives around Manaaki Tangata (human capital) and Tātai Hononga (social capital).

In reality, this is a 10-year journey for which considerable planning and diligence is needed to ensure the money is spent in the most effective way possible, and that is what we are striving to do.

This has meant we have to fund a strategic approach that sees, as a priority, working with hapū, marae, community and landowners to fence and plant waterways and wetlands in the catchment and significantly reduce sediment entering our streams.

Preparing for action has also meant assessing the capability of nurseries to provide the number of trees required, ensuring that there is a trained and capable workforce to do the mahi, and identifying how marae and community groups are engaged in the process.

Kaipara Uri has always upheld their roles as the Kaitiaki of Kaipara Moana, exercised by the occupation of the rohe over the last 800 years. Others of us who own land throughout the catchment will also be encouraged to uphold their respective Kaitiaki responsibilities for the period of our stewardship.

The Kaipara Moana Remediation programme requires a collaborative effort from everyone, to achieve collective success. The landowner grant scheme and the hapū and community partnerships scheme will provide money to assist us all and our responsibilities in exercising kaitiakitanga.

Our aspirations are that we will begin a process that will provide a pattern for decades and even centuries to come. This will enable Kaipara Moana to heal, restore its mauri, rejuvenate kai moana, replenish fish stocks, and provide increased commercial and recreation opportunities that will benefit us all. We look forward to partnering with you all in realising this aspiration.
