The Chair declared the meeting open at 3.06pm. Discussion

The Kaipara Maurikura team sought direction from the KMR Joint Committee Members present on three specific (pilot) initiatives that were time sensitive in order to progress work to scale up the KMR programme at pace, in line with the KMR Memorandum of Understanding. The three pilot initiatives all aim to reduce sediment flows into the Kaipara Moana by achieving ongoing and significant uplift in planting and other sediment remediation activities through KMR grants from winter 2023.

The following discussion points were presented to the Joint Committee members in attendance, and direction sought for the proposed initiatives:

1: Pre-ordering of plants

- Do you agree that KMR pre-order 400,000 native plants in December 2022, in line with the KMR Nursery Strategy?
- Do you agree with the proposed approach to sharing orders across nurseries (i.e. order size correlates to nursery size (FTE))?

The members present agreed with the direction suggested above, and the Kaipara Maurikura took a direction to work with accredited KMR nurseries to engage, communicate and operationalise pre-ordering before Christmas.

2: Extending native planting into areas of high sediment yield risk to waterways

- Do you support KMR trialling the funding of native planting in areas with high sediment yield risk to waterways to accelerate planting to reduce sediment from 2023?
- Do you support KMR implementing this immediately, in advance of Soil Conservation decisions in February 2023?

The members present supported the direction suggested above. The Kaipara Maurikura took a direction to clarify and roll out the operational settings required to implement this initiative.

3: Flagship (Navigator) projects

- Do you agree with KMR introducing flagship (Navigator) projects to act as demonstration sites for approaches to reduce sediment flows at scale and pace?
- Do you agree with KMR promoting flagship (Navigator) projects and seeking expressions of interest (EOIs) from December 2022 to enable potential projects to prepare for an EOI in February 2023?
- Do you agree that KMR seek flagship (Navigator) projects that demonstrate a range of good practices, which could potentially involve exotic as well as native tree species, and constructed sediment reduction options?

The members present agreed with the directions suggested above. The Kaipara Maurikura took a direction to communicate and operationalise these approaches ahead of winter 2023. It was noted that the settings and investments in Navigator projects do not prejudge future Joint Committee decisions on the KMR Soil Conservation Strategy and Action Plan, which is likely to be workshopped with the Joint Committee in March 2023 with decisions sought in May 2023.

A report-back to the Joint Committee will be made on these three pilot initiatives in early 2023.
