Secretariat Note:

Report from Justine Daw, Pou Tātaki

Secretariat Note:

In the interests of time, formal acknowledgements of Justine's exceptional tenure as Pou Tātaki were deferred to the subsequent farewell event. At that event, multiple heartfelt speeches celebrated Justine's profound contributions to the Kaipara Moana, her visionary leadership, unwavering passion, and steadfast dedication. Speakers reflected on her tenacity and ability to inspire collective action, noting that her impact will resonate well beyond her time in the role.

UPDATE ON MONITORING (verbal items)

Presentations were given by Jenni Gadd (AC) and Richard Griffiths (NRC) on the 2025 State of Environment monitoring results, both published (Auckland Council) and early-stage monitoring results (NRC). Duncan Kervell (KMR) also provided an overview of the planned case studies to be developed in respect of localised stream health.

Secretariat note:

Member Brewer requested that contact be made with Auckland Council presenters following the meeting for further dialogue [Complete]. Member Curtis-Connelly asked Presenter Richard Griffiths whether local marae in relevant areas could potentially partner with NRC on monitoring data collection, noting that the current monitoring intervals were lengthy. While NRC was open to this possibility for coastal monitoring, Presenter Griffiths acknowledged the health and safety considerations and practical difficulties in monitoring some of the more remote monitoring sites.

Member Craw asked whether more regular sampling and reporting would provide additional benefits to council and community. In response, Presenter Griffiths indicated that NRC was already undertaking some more regular sampling in the Kaipara Harbour, including water quality and sediment quality monitoring as part of other programmes. The sediment monitoring programme, which is primarily for urban contaminants includes sediment grain size analysis which will be of use building a more complete picture of patterns of

changes to sediment in the harbour. A more regular repeat of the ecological survey undertaken this year would be difficult due to the cost and time resources involved.
